- ➔ **Istzustand:** signifikante Überschreitung der EU-weit vorgegebenen **Immissionswerte für PM<sub>10</sub>** in mehreren sächsischen Ballungsräumen
- ➔ **zz.:** Erarbeitung und Beginn der Umsetzung von Luftreinhalteplänen in mehreren sächsischen (Groß-)Städten
- ➔ **nach wie vor notwendig:** vertiefte Klärung von Verursacher und Prozessketten
  - **Punkt- und Flächenquellen**
  - **primäre und sekundäre Emissionen**
  - **Nah- und Ferntransport**

### Chemie-Transport-Modell

#### MUSCAT

(Multi-Scale Atmosphäric Transport Modell)

- hochaufgelöste online-Verknüpfung in „Echtzeit“
- Steuerung der physikalisch-chemischen Emissions-, Transport- und Umwandlungsprozesse
- äußerst variable und unabhängige Teilprozeduren
- Verarbeitung hochgradig nichtlinear gekoppelter Gleichungen und unterschiedlicher Zeitskalen
- variable, von LM unabhängige, horizontale und vertikale Nestung

RACM

- umfasst 76 reaktive Spurengase in 239 Reaktionen

infolge der GFA-Emissionen im Winter**


